The Lebanon County Area Agency on Aging (LCAAA) is distributing SMNP checks to seniors 60+ in Lebanon County

The purpose of the SFMNP, administered by the Pennsylvania Department of Agriculture is (a) to provide seniors resources in the form of fresh, nutritious, unprepared fruits & vegetables from farmers' markets and (b) to expand the awareness and use of farmers' markets.

WHAT TO KNOW FOR 2022

Eligibility- Eligible persons must be Lebanon County Residents & must be 60 years of age or older during 2021. Household Income guidelines are:

 1 Person- \$25,142
 5 people- \$60,070

 2 People- \$33,874
 6 People- \$68,802

 3 people- \$42,606
 7 People- \$77,534

 4 people- \$51,338
 8 People- \$86,266

Benefits- Eligible persons receive four-\$6.00 checks for a total benefit of \$24.00 **one time** during the program year.

Time Frames- Check distribution between **June 1 and Sept. 30**, or until all gone. Checks **expire on November 30**.

Eligible Food— SFMNP checks may only be used to purchase produce grown in Pennsylvania. SFMNP checks may not be used at grocery stores.

LCAAA will review applications for accuracy & mail SFMNP checks to eligible participants.
